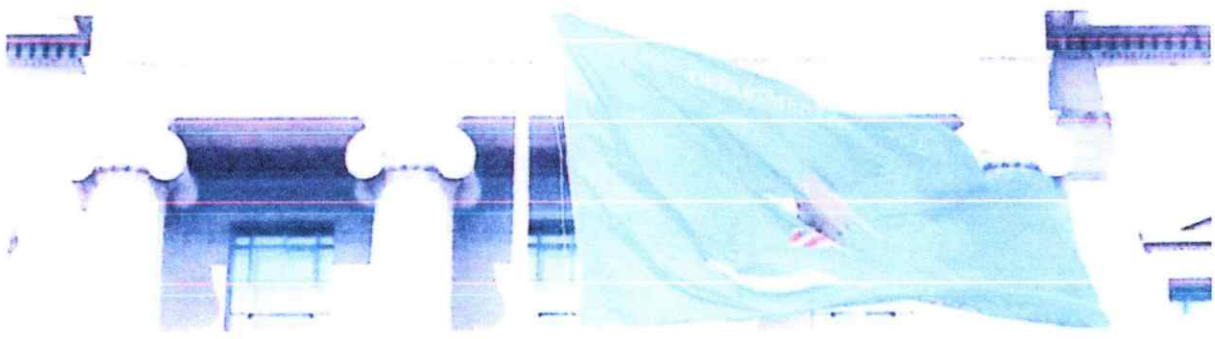

Dear Attorney General Jeff Sessions, my name is William Parrott and I'm writing this letter to ask for your help. I am a targeted individual and I assume other targeted individuals have contacted you in the past asking for your help too, but there wasn't enough evidence to prove their story. There are millions of dollars plus several eye witnesses from my National Guard unit and my x-wife is a witness too. I have enclosed my story that I have on a blog post along with other victims' stories and several videos that can be reviewed on a computer. I consider myself to be an expert on recognizing mind control crimes, such as those mass shootings. I wrote Major Nidal Hasan, the Fort Hood shooter a letter a while back to ask him a few questions about what his life was like for him for about two years prior to the shooting but Paulette D Leach at the Fort Leavenworth correctional facility wouldn't give it to him, she said that kind of information would disrupt her facility and she also said that any other mail with that kind of content would be rejected too. Instead she turned it over to the F.B.I. and a few months later two Deputy's from the Hawkins County Sheriff's office escorted two F.B.I. agents to my home to question me about the letter I wrote to Major Hasin and accused me of collusion with an enemy combatant. Before they left I practically begged the senior agent to investigate my story and he replied with a hateful tone that he would, and then turned and walked away, then his partner walked up to me and said hey William, and I turned and looked at him and he was smiling from ear to ear shaking his head no then he walked away. So, I'm not having a lot of luck with the F.B.I. I have a hard time watching those mass shootings on the television especially those school shootings, and I know in my heart that most of those shootings are mind control crimes done with E.L.F. microwave technology like the Washington Navy ship yard shooting. I wrote a letter to Sheriff Ronnie Lawson in my county and asked for his help also, but I haven't heard anything back from him yet. If you google targeted individuals, there are hundreds of victims on there from the United States and several other countries, but the problem is, there is no evidence. I think possibly that I maybe the only person that has enough evidence to get a conviction, and the reason there is evidence in my case is because I'm one of the first people that was experimented on when this technology was first developed and tested on the public, but since the 1980s the C.I.A. has expanded their agenda and stopped spending millions on testing. They got smarter and started experimenting in much the same fashion but with out paying huge bribes to citizens to help their contractors and leaving a huge paper trail like they did in

my case. I promise my story is true and with your help we can put a stop to most of those mass shootings and make our schools safer for our grandchildren.
