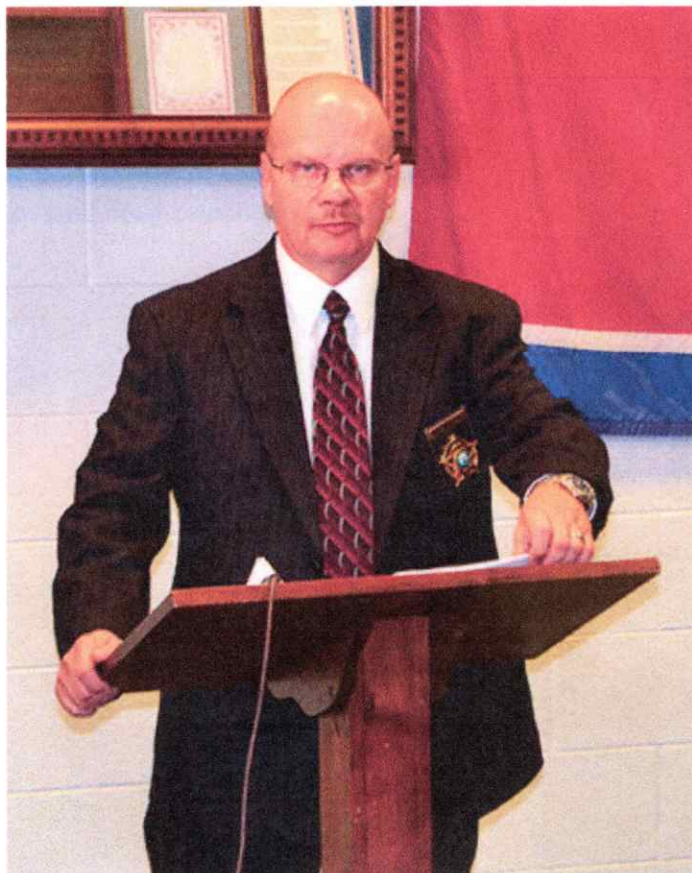


Sheriff Ronnie Lawson

Dear Sheriff Ronnie Lawson, my name is William Parrott and we met at my home [REDACTED] back in January. I am writing you this letter because after thinking back on that frigid day, it seemed like you were interested in my story and I noticed the shorter F.B.I. agent was distracting you when you were trying to get closer, so you couldn't hear my conversation with the taller agent. You probably didn't notice when I practically begged the taller agent to just check out my story and he turned back at me and said in a hateful tone saying I will. Then when the shorter agent walked past me he stopped and said hey William, he had a smile on his face from ear to ear and he was shaking his head no at the same time then he walked away. It took the wind out of my sails, I thought they were there to investigate my story. I guess I had a broken look on my face because the taller agent was looking back and watching the exchange and when his partner caught up to him, I heard him ask what he said to me. If you are interested in my story and want to maybe see one of those computer devices that those C.I.A. contractors used on me, all you have to do is stop the vehicles with Knox county plates and do a routine check with in a two-mile radius of my home. They usually travel up 11w from Corrington and Knoxville to get to where my family and I live. The item you will be looking for is kept in a ten-inch-thick by about eighteen inches long aluminum carrying case, the item itself looks like a computer with a microphone attached to it. I can't promise they are still stalking me, but they said they use to stay on the boy scout camp but after I contacted the F.B.I. they said the F.B.I. set up shop on the boy scout camp, so they bought a piece of property in Lee Valley, so they could monitor me while I was home on weekends and they wouldn't look suspicious sitting on the side of the road.
