Freight Delivery Instruction (#)

Vehicles transporting freight destined for DHS Headquarters (HQ) Facilities in Washington, DC, Arlington, Alexandria or the Transportation Security Operations Center are required to undergo security inspections at the Federal Protective Service (FPS) Vehicle Inspection Facility (VIF) prior to making a freight delivery. Freight delivery vehicles must arrive at each destination with a FPS seal attached. *All HAZMAT vehicles must be processed through the VIF.*

In instances where there are multiple DHS-HQ destinations for one vehicle, the driver will be issued multiple seals at the VIF. All commercial delivery services such as FEDEX, UPS, DHL, are not permitted to make deliveries directly to DHS-HQ Facilities located in Washington, DC, Arlington or Alexandria. As outlined below, the size of the delivery determines whether the cargo should be processed through the VIF or a Remote Delivery Site (RDS).

The VIF is available for inspection of vehicles carrying DHS freight between the hours of 5:00 am to 5:00 pm daily M-F. The VIF is also available from 5:00 am to 1:00 pm on Saturdays. The VIF is located at 1880 2nd Street Southwest Washington, DC. Delivery vehicles will also be subjected to explosive detection dogs at the Government's discretion. Please make sure the freight invoice has special instruction for delivery through the FPS facility to final destination.

Two Step Freight Delivery Process

1. Freight delivery truck must undergo security inspection at the FPS VIF address below.

Mail Delivery Instruction (#)

Mail deliveries using the US Postal Service or a commercial express package service provider such as DHL, UPS or FedEx should be addressed using the five line address format as displayed below. The Department of Homeland Security (DHS) has incorporated its 4 digit mail stop system with the US Postal Service ZIP + 4 codes to identify the final delivery location.

Dear Secretary of Homeland Security Kirstjen M. Nielsen, my name is William E. Parrott of [REDACTED]. I'm writing you this letter to ask for your help because I'm a targeted individual. I have been targeted by Jimmy Ray Roberts and his half-brother Gerry Roberts along with James Roberts and his son James Roberts Junior and Jimmy Ray Roberts other son from his current marriage Curtis Roberts and his son too, but I don't know his name. Gerry Roberts son and grandson along with several of their cousins from Knoxville Tn. Are part of the team stalking me also for the past 39 years with a mind reading computer. It operates with extreme low frequency microwaves. [ELF] the same frequency that the human body operates on. It also has a microphone attached to it, so the operator can talk to their victims' brains. Some victims call this voice to skull. There is a mountain of evidence to prove my story. I'm a long-haul truck driver and I have traveled over four million miles on U.S. and Canadian highways in the past thirty-five years. The company that I work for now has a record of every mile and every city along with the dates that I have visited from my hire date on June 28, 2006. To the present day. The Roberts family followed me every mile of my career seven days a week and twenty-four hours a day and left a paper trail of hotel, food, and gas receipts mostly paid with credit cards and car payments along with house payments on the house they purchased near my home to use for their office that they have turned in on their income taxes every year like all contractors do. These receipts can be cross referenced with my trip miles and dates. I have included all the city's that I have either delivered to or picked up at since my employment with Big G Express. The Roberts family are C I A contractors. I'm asking for your help to get justice for my family, myself and all the other targeted individuals that don't have any proof, all they have is their Prayers. I truly believe that 99 percent of all mass shootings are caused by E L F technology and a lot of mass shooters claim that our Government was stalking and torturing them to get them to commit such crimes, like Jared Lee Laughner, Aaron Alexis, Myron May, Esteban Santiago-Ruiz. And many more. All these shooters claim to be targeted individuals like me, and they claim that they committed those shootings to get the attention of the F.B.I. and the public to raise awareness of these horrific crimes and to outrage the public into demanding investigations. Those shooters figured that by killing children and innocent civilians that there would be a big outrage over the Government ELF targeting and torture of targeted individuals. But nobody came to their aid, they just got

ignored and wrote off as nut jobs. Then the courts sent them to different prisons and cemeteries. Nobody can write to the shooters that survived to get their story that the news didn't tell about. I tried, my mail to Jared Lee Laughner got refused and sent back to me. My letter to Major Nidal Hasin got turned over to the F.B.I. then Paulette E. Leach of the Ft. Leavenworth correctional facility wrote me a letter saying that my letter was rejected and any more mail with that type of information would be rejected also. Back in January of this year 2018 two F.B.I. agents from 2620 Knob creek rd. Johnson City Tn.37604 along with two Hawkins County Sheriff's Deputy's from Rogersville Tn. came to my home to ask me about the letter that I had written to Nidal Hasin. The senior agent showed me a package and asked if I had sent it to Major Hasin, I said yes, then he told me that the Bureau considered what I did to be an act of collusion with an enemy combatant. I explained that I truly believed that Major Nidal Hasin was a targeted individual and I was only trying to see if he experienced any of the symptoms that the rest of us had. He then asked if I intended to write any more letters to him and I said no. I tried to get him to go to my ex-wife's house about a mile away and ask her about the six hundred thousand dollars that she and her family received for their involvement in my story back in 1980 that I have described in my blog that I have included in my package to you, but they didn't seem interested. On Friday, March 23, 2018 my ex father in law Billy Bruce Johns died. He was a valuable witness and his income tax records will show the six hundred thousand dollars. As they were walking away I practically begged the senior agent to investigate my story, I promised him that there was evidence, he turned around and said with a hateful tone that he would, but It seemed like it made him angry that I had asked. when his partner Special Agent Kacy passed by me he said hey William, I turned and looked at him and he had a smile on his face from ear to ear and he was shaking his head no at the same time. I now know that those guys never intended to help me. They just wanted to shut me up. I have sent you three videos of Myron May that he made just before he shot three people at the Florida State University. He was explaining his story and apologizing to his victims before he shot them, and he was saying good bye to all too. I have also included several other targeted individuals story's on videos that you can watch on your computer along with a copy of my story on a blog post that explains my story in greater detail, and the web site for www.targetedjustice.com These victims on this web site are mostly professional people banding together trying to survive long


enough for help to arrive. And I also included a few other victims' story's that I printed off the internet when I googled targeted individuals. The targeting and torture of American citizens and individuals from other countries are on the rise since my targeting started back in 1979. I honestly believe with your help and with the overwhelming evidence in my case, together we can save several children's lives from school and church shootings, and many other lives of mass shootings too. This would also send a message to other Government contractors out there that are engaging in the inhumane targeting of American citizens that if they get caught they will spend the rest of their lives in a penitentiary.
