- If possible, [email us!](#) This is the fastest way to get your message to President Trump.

- If you write a letter, please consider typing it on an 8 1/2 by 11 inch sheet of paper. If you hand-write your letter, please consider using pen and writing as neatly as possible.
- Please include your return address on your letter as well as your envelope. If you have an email address, please consider including that as well.
- And finally, be sure to include the full address of the White House to make sure your message gets to us as quickly and directly as possible:

Sending Gifts

The President and the First Lady strongly encourage all Americans to consider sending contributions to their favorite charities in lieu of gifts to the First Family.

For security reasons, please do not send perishable gifts —such as food, liquids, or flowers — to the White house. The White House is unable to accept cash, checks, bonds, gift certificates, foreign currency, or other monetary equivalents. Additionally, items sent to the White House are often significantly delayed and can be irreparably harmed during the security screening process. Therefore, please do not send items of personal importance, such as family photographs, because items may not be returned.

Dear President Trump, my name is William Eugene Parrott. My social security number is [REDACTED] and I live at [REDACTED] with my wife Mona and two of our grandsons Austin and Aiden. The last time I wrote a letter to a United States President was thirty- eight years ago when President Ronald Reagan was our President. I haven't really trusted any of them since until now. I always thought that all the Presidents before you knew about extreme low frequency micro wave technology and wouldn't help the hundreds of targeted individuals like me that has sent numerous letters to congress and the President's office before and got ignored because the CIA told him and most of congress that this technology would keep Americans safe and they needed to experiment on citizens to figure out how to use it as a weapon. the reason I am writing this letter to you is because I believe God laid it on my heart to ask you for help and I promise that my story is the truth and I'm probably the only targeted individual that has eye witnesses and millions of dollars of proof. They killed my mother because she was a witness and they said they are thinking about killing my father too, I have enclosed a brief account of my life story that is online in a blog post, and some videos and stories of other targeted individuals. The problem I am having is the F.B.I. won't investigate my story to bring my attackers to justice and shine the light on this technology for the evil it is being used for. I truly believe this technology is the cause of ninety nine percent of all mass shootings. I tried to contact Major Nidal Hasan, the Ft. Hood shooter to tell him my story and send him other victims stories so he could read them and see if he thought he might have been programed into committing this horrible act because the people he shot was his brothers and sisters and I truly believe this was a mind control crime committed by the same equipment used on me and hundreds of other victims from here and other countrys, but the prison officials gave my package to the F.B.I. and he never received it. The F.B.I. sent two agents out to my home escorted by Hawkins County Sheriff Ronnie Lawson and a Deputy to accuse me of collusion with an enemy combatant but they didn't want to investigate my story and now I have no way to move forward with my investigations with mass shooters to get their stories that the media wouldn't put on television for the entire world to see. Then I called up to the prison in Minnesota where Jared Lee Laughner is being housed to get his mailing address so I could send him the same material, but the man and lady that answered the phone up there seemed overly concerned and nervous as to why I wanted to contact him unlike the folks at Ft. Leavenworth prison, and they wouldn't give it to me after they found out that I was doing an inquiry about

him hearing voices and that I was going to see if he would write his story in detail explaining the little thoughts that most people would feel was insignificant that lead up to the shooting so I could post it on my blog to try to expose the truth behind mass shootings. I had to google his location and address and when my package arrived they didn't open it and turn it over to the F.B.I. like the folks at Ft. Leavenworth did, they just stamped refused on it and sent it back to me like they were trying to hide the truth. I feel that he has a story to tell that he didn't get a chance to tell in court like he probably had planned on that will shed light on what was really going on in his head that lead up to his mass shooting. I'm thinking he might have committed that act to get an investigation started over the voices in his head so his attackers would leave him alone and he could possibly say he was forced into it and use that excuse as a defense in court.
