Dear F.B.I. Special Agent Karen L. Ferguson, my name is William Eugene Parrott of [REDACTED]. I'm sending you this letter because I wrote a letter to you back on September 29th, 2018 asking for your help. That was almost 6 months ago. I haven't heard anything from you and most everyone else that I've called upon for help. I'm wondering if you are ignoring me and the mountain of evidence in my case? I get the uncomfortable feeling that you are investigating me instead of my stalkers. It seems to me that you would have already contacted me and offered your assistance if you are on the up and up. Is this a cover up? If you have no intention of helping my family and me, I respectfully ask that you put it in writing and send it to me. As I mentioned in my first letter, the Roberts family has been gang stalking, torturing and committing genocide against the American people for over 40 years. They have been testing and practicing with those NASA computers/ mind reading devices on my family and me along with every other citizen that they encounter daily for decades. Where does it stop? You have my work history and their credit card, Verizon phone records, tax papers and banking history to prove that they are stalking me from State to State. Do you not care that this is happening on your watch? Is there any honor in the F.B.I. any more? The last time I talked to Jim Roberts, he said that he made millions from this project. His son James Roberts said that he has made over 12 million dollars working for Jim on this project because he is the boss now since Jim is 84 years old. The rest of his family that is working with them said that they have made over 10 million dollars stalking and torturing me for the past 39 years. That money should be easy to find and hard to explain. Jim's half-brother Gerry Roberts said that he made enough money to retire 20 years ago so he quit the project and went into real-estate so he could be home with his wife every night. But I think he retired from the real-estate business and now he is stalking me again along with his wife and Jim's wife Wanda. They said that they have a large provost bus that they ride in. James said he has a large bus also, but his bus is a little older than Jim's. James wife also travels with the gang too. She said her name is Kathy. I also wrote The Honorable Kirdtjen M. Nielsen back on September 29th, 2018 and several other people asking for their help and most of them never did answer my letters. I didn't even get the little green card back in the mail back from the two certified letters I sent to the department of homeland security. I received a letter concerning my physical, emotional and mental health well-being from Kimberly T. Konkel, Senior Public Health Adviser, Center for Mental Health Services at 5600

Fishers Lane 14N46 Rockville, Md 20852 because of the two letters that I had sent to President Trump. It seems to me that the White House Chief of Staff is diverting the mail that I'm trying to send to President Trump to her for some unknown reason. The Tennessee Bureau of Investigation Special Agent JJ Sipos called me on the phone last year saying that the F.B.I. has jurisdiction over my story and that he couldn't help me but none of the F.B.I. people that I have contacted so far seem to be interested in helping me get justice for this cruel and inhumane treatment that my family and I have had to endure for decades from the Roberts family. All my letters that concerns my abuse and neglect on behalf of our Government agencies and CIA contractors have been sent certified mail. As you know, I've recently gained possession of my work history for the past twelve years from the company I'm currently employed with that proves my story is real and true and not just a simple mental illness situation. I'm asking once again that you read my story and help my family and me along with all the rest of the victims that weir crippled or killed for money and shits and giggles get justice. I'm also asking that after you read my story, please send this package to some of your investigative professional friends that you trust to investigate and cross reference my work history with the people that I'm also sending in this package that will prove that I have been gang stalked for over 1.4 million miles while I've been working for my present employer and for the previous 36 years that I have been a long haul truck driver. As I was saying in my first letter to The Tennessee Bureau of Investigation last year, back in 1979 I was targeted by Jimmy Ray Roberts and his half-brother Gerry Roberts of Knoxville Tn. He was a good friend of gambler Billy Ray Lee of Morristown Tn. Somehow Jim got a job testing NASA computers, also known as mind reading devices for the C.I.A., Jim told me that his dad Sam Cecil Roberts worked for the CIA and that's how he gained employment with them, but I don't know for sure if that's true. The computer device that they are using on my family and me is a mind reading/mind control device that works from extreme low frequency micro wave technology. [E.L.F.] The same stuff that the Washington Navy ship yard shooter Aaron Alexis complained about before he killed twelve people and wounded three others. Esteban Santiago complained of the same thing just before he shot several people at the Hollywood Florida airport. Attorney Myron May made three videos begging for help and put them on you tube just before he shot three people at the Florida State University. And then he was shot over 30 times and killed. Jared Lee Laughner Killed a Federal

Judge and a nine-year-old girl along with several other people and nearly killed congresswoman Gabrielle Giffords in a supermarket parking lot in Casas Adobes Arizona, he also claimed to be targeted with mind control by our Government. I sent Jared Lee Laughner a letter at the facility where he is being housed in Minnesota and the people in charge there refused to give it to him, instead they marked it refused and sent it back to me. It seems that a conspiracy is going on here. The people in charge of those mass shooters won't let anyone talk to them for some curious reason. I also truly believe that Major Nidal Hasan was also programed by this technology without his knowledge to commit the first mass shooting at the Ft. Hood Tx. Facility. The people in charge of him won't let me talk to him either. All these shooters are called Manchurian candidates. I promise that if you help me prove my story and expose this inhumane treatment of my family and me and countless other citizens, you will make history on helping stop mass shootings and gang stalking. I have already sent President Trump several hours of testimony on videos of other targeted individuals that I burned from you tube so that he could watch them on his computer. But the Whitehouse chief of staff didn't give them to him as I mentioned above. You can google targeted individuals and [E.L.F.] mind control crimes to see for yourself that these types of crimes are going on all over the United States and other countries as well. Also check you tube to get several other victims' stories that resembles my story. As far as I know, I'm the only targeted individual that has undeniable proof along with eye witnesses from my National Guard service that proves these types of crimes are real and happening. If you will help me maybe you will help prevent the next school shooting or other mass shootings that I see the news people talk about every year. The C.I.A. gave Jim four of those NASA computers to test on the public to see if it could be used as a weapon back in 1973. He hired his half brother Gerry Roberts of Corrington Tn. To help, along with at least three of their sons, James, Jerold and Curtis and several grandsons as they graduated high school along with several other family members, but I don't know their names. I have written my story down as best I can on a blog and I'm sending another copy of it with this letter to you. My penmanship isn't the best, I don't think I'll be winning a Pulitzer prize any time soon. I have written two letters to President Donald Trump that I mentioned at the top of this letter, one letter to Paulette D Leach, she runs the correctional facility at Ft. Leavenworth Ks. Where Major Nidal Hasan the first Ft. Hood shooter is being housed, and this is the second letter to F.B.I. supervisor

Sowers of the Knoxville Tn. office, one letter to Pastor John Hagee of San Antonio Tx, one letter to F.B.I. Special Agent Casey of 2620 Knob Creek Rd. Johnson City Tn. two letters to the Secretary of Homeland Security Kirstjen M. Neilson of Washington DC, three letters to the Tennessee Bureau of Investigation of Knoxville Tn., one letter to Dibble & Miller. law firm of Rochester N.Y., one letter to Tennessee Congressman John Duncan of Washington DC., one letter to F.B.I. director Robert Muller of Washington DC, one letter to Tennessee Senator Lamar Alexander of Washington DC, two letters to Tennessee Attorney General Herbert H. Slatery III of Nashville Tn., one letter to F.B.I. Director Christopher A. Wray of Washington DC, one letter to Sean Hannity of Fox news of New York NY., two letters to the 84th Attorney General of the United States Jeff Sessions of Washington DC., and one letter to the First Lady of The United States Melania Trump of Washington DC., Two letters to Hawkins county Sheriff Ronnie Lawson of Rogersville Tn. one letter to Sheriff Esco R. Jarnagan of Morristown Tn. in Hamblen county, and one letter to Vice President Mike Pence, one letter to wbir channel 10 in Knoxville Tn., one letter to Alex Jones of Austin Tx. and I sent one letter back to Kimberly T. Konkel, MSW Senior Public Health Advisor at the center for Mental Health services SAMHSA 5600 Fishers Lane, 14N46 Rockville Md. 20852 with my work history, blog and videos of other targeted individuals that I burned from you tube so she could check for herself. One letter to House speaker Nancy Pelosi, one letter to Tucker Carlson of fox news in New York N.Y., and one letter to acting Attorney General Whitaker of Washington D.C., one letter to U.S. Attorney James Douglas Overbey of Greenville Tn. I don't understand, there is a mountain of evidence and several eye witnesses and nobody seems to care or wants to help stop the mass shootings and the insane treatment of my family and me and other citizens. The only person I've heard back from is T.B.I. Special Agent JJ Sipos, that I mentioned in the top of this letter, he called me on the phone and said that he couldn't help me because the F.B.I. has jurisdiction. And Sheriff Esco R. Jarnagan sent me a letter with his concern. And maybe he is investigating my story. I am sending you a copy of all the letters that I've sent out so far asking for help. I'm not the smartest person on this planet but it's clear to me that this looks like a cover. As I was also saying at the top of this letter, I have my work history for the past twelve years that shows the places and dates that I have picked up loads from and delivered to across the United State. I have run over one point

four million miles for Big G Express out of Shelbyville Tn. I have been a long-haul tractor trailer driver since 1982 and I have driven over four million miles in my trucking career across the United States and Canada. C.I.A. contractors are like all contractors, they must save all their credit card, hotel, fuel, phone and food receipts to deduct from their Federal income tax every quarter to recover their out of pocket expenses, Verizon should have a lengthy record of most of their calls and locations that can be cross referenced with my work history sheets. Is there anything or anyone that you can think of that possibly will help my family and me get justice for this inhumane mind control crime and gang stalking that has been committed against us? There was a Trailways bus crash that happened back in 1973 with a tractor trailer on highway 11w near Bean Station Tennessee Jim told me that that was one of the first crashes that he caused using a NASA computer he also said that he crashed another Trailways or Greyhound bus in that same area a little later on that killed several more people, and for several years after that he and his family gave highway 11w the nickname bloody 11w. from all the men, woman and children that they killed in automobile crashes on that highway just practicing. Jim said that the device they are using has a recorder built in, and they record everything. Then they send the recordings to the C.I.A. He also said that he has an extensive library collection of recordings that he keeps for himself. [E.L.F.] technology can be used to cause heart attacks, especially if the victim has a pace maker, and lots of other physical and emotional pain. The Roberts family is responsible for several hundreds of deaths that most people don't know about. Jim's grand son James Roberts told me that he has already killed twenty-three people and he is only twenty-four years old. He also said that he tries to kill two people every day on his way from his home in Knoxville Tn. To my Home when I'm on my home time to catch up with his relatives that has been working on this program longer than him.
