enforcement officer for Hamblen County. He was born and raised in Hamblen County. He is a graduate of the Hamblen County School System, East Tennessee State University (BS Degree in Criminal Justice), and a graduate of the FBI National Academy where he studied Leadership and Management. Sheriff Jarnagin is a veteran of Foreign Wars and received an Honorable Discharge from military service during the Vietnam War. He has investigated over 6,000 criminal cases and named Lawman of the Year three times.

The Hamblen County Sheriff's Department was established in 1870 and the jail was constructed for less than \$3,000. Our current jail has 255 beds. The population of the county is approaching 63,000 people. The county has a total of 176 square miles of which 15 square miles is water.

The duties of the Sheriff have increased as administrative procedures, Court decisions and requirement of the laws have brought about sophisticated and technical advancements to law enforcement. The Hamblen County Sheriff's Department basic units are: Patrol, Detective, Narcotic, Administrative, Court Room Security, and the Jail.

Dear Sheriff Jarnagin, my name is William Eugene Parrott of [REDACTED]. I'm sending you this letter because I wrote you a letter back on December 8th, 2018. I don't want to bother you and I realize you live in a different county than me but you're the most honest and wisest law man that I know, I need to ask if you know anyone that I should contact for help next. I have from three to nine different voices in my head from three to nine different people every day constantly harassing me and saying they are going to kill me and my wife. The voices in my head are threatening and calling me names and just being rude all the time I'm awake. I truly think they are trying to drive me crazy and cause me to have a nervous breakdown. I have contacted every law enforcement agency that I can think of and I can't get any help from any of them so far. Have you or anyone you know ever reported this kind of horrific crime on a United States family and got ignored and swept under the rug like my family and I have? With the level of neglect going on here, it's obvious, I'm telling the truth and my story is real. I have enclosed another video in this package that explains exactly what a targeted individual is just in case you have lost the last one. I have also put several other videos from other credible targeted individuals in with it to show you I'm not the only targeted individual. Over the past several months I have written several letters to several different F.B.I. agents and to several State and Federal Government officials asking for their help. I haven't heard anything back from most of them. Like I was saying, they are ignoring me and the mountain of evidence in my case. It looks to me like they are trying to cover up this crime. I get the uncomfortable feeling that the F.B.I. is investigating me instead of my stalkers. It seems to me that the F.B.I. would have already contacted me and offered their assistance if they are on the up and up. I'm also writing this letter to ask if would be possible for you to investigate my story? I'm sending you most of the names of the people involved and a background check on some of them too. As I mentioned in my first letter to the F.B.I. and to several other Government authority figures, Jim R. Roberts and his half-brother Gerry Roberts of Knoxville Tennessee along with several of their family members has been gang stalking and torturing me and my family and committing genocide against the American people for over 40 years. They have been testing and practicing with NASA computers/ mind reading devices on my family and me along with every other citizen that they encounter daily for several decades. There is a mountain of evidence in my case along with all my fellow National Guardsmen that I served

with back in the late seventy's and early eighty's that seen the equipment that was used on me and they witnessed the attack by Gerry Roberts and one of his relatives while I was at my last summer camp at Ft. Stewart Ga., I think his name is Roy Roberts. My blog explains my story in greater detail. God knows the F.B.I. has the Roberts family's credit card history, hotel receipts, phone records, tax papers and banking history to prove that they are stalking me from State to State. I talk to Jim Roberts daily; he says that he has made millions from this project. And It's hard to believe that an 85-year-old man is stalking me from state to state, but he is. His son James Roberts said that he has made over 12 million dollars working for Jim on this project and that he is the boss now since Jim is 84 years old. All the money from the CIA still goes into Jim Robert's bank account and Jim still pays his family monthly as sub-contractors. The rest of Jim's family that is working with them said that they all have made over 10 million dollars each stalking and torturing me for the past 40 years that they have been employed on the project, except For James son, James the third, and that's because he is only twenty-four years old. James the third told me that he is married and has a young child and one on the way. Jim's half-brother Gerry Roberts said that he made enough money to retire 20 years after he started working on this project but he wasn't old enough to officially retire so he quit the program and went into the real-estate business in the Knoxville Tennessee area so he could be home with his wife every night. But he said that he is retired from the real-estate business now and he is stalking me again just to give moral support and his expert advice to his half-brother Jim because of the letters that I have been writing asking for help. Now I have him inside my head again. He seems to think he's exempt from prosecution since he was out for twenty years and he isn't getting paid this time, but I still hear his voice in my head every day. Gerry's wife and Jim's 74-year-old wife Wanda also travel along with the group. They said that they have a large Prevost bus that they follow me in. James Jr. said he has a large bus also that he and his wife travel in, but his bus is a little older than Jim's and he has been having a lot of break down trouble with it. Timothy Curtis Roberts and his wife Kathy also travel with the group. I have written two letters to The Honorable Kirdtjen M. Nielsen, asking for help, the first back on September 29th, 2018 and several other people asking for their help also, none of them has answered my letters. I'm beginning to question their commitment to the oath of office that they swore to uphold to the American people too. I received a letter concerning my physical,

emotional and mental health well-being from Kimberly T. Konkel, Senior Public Health Adviser, Center for Mental Health Services at 5600 Fishers Lane 14N46 Rockville, Md 20852 because of the first two letters that I had sent to President Trump. The White House Chief of Staff keeps diverting the mail that I am trying to send to him to her for some unknown reason. I think he knows if President Trump ever reads my letters, someone is going to jail. The Tennessee Bureau of Investigation Special Agent JJ Sipos from the Knoxville Tennessee office called me on the phone last year saying that the F.B.I. has jurisdiction over my story and that he can't help me. He almost seemed relieved that he didn't have to take a chance of being targeted by the Roberts family himself for intervening on my behalf. But as I mentioned earlier, none of the F.B.I. people that I have contacted so far seem to be interested in helping me get justice for this cruel and inhumane treatment that my family and I have had to endure for decades or stop them from stalking me. I have recently gained possession of my work history for the past twelve and a half years from the company that I'm currently employed with that proves my story is real and not just a simple mental illness situation. All these documents will help prove that I am currently and have been gang stalked for over 1.4 million miles while I've been working for my present employer. I have been a long-haul truck driver for over 36 years. There is a mountain of evidence that proves my story is real. Again, I am saying that back in 1979 I was targeted by Jimmy Ray Roberts and his half-brother Gerry Roberts of Knoxville Tn. And the targeting, torture and stalking is still going on to this day, forty years later. Jim told me that his dad Sam Cecil Roberts worked for the CIA and that's how he gained employment with them. But I don't know if that is true or not. He seems to be a habitual liar and he's criminally insane. The computer device that they are using on my family and me is a mind reading/mind control device that works from extreme low frequency microwave technology. [E.L.F.] The same stuff that the Washington Navy shipyard shooter Aaron Alexis complained about before he killed twelve people and wounded three others. National Guardsmen Esteban Santiago complained of the same thing just before he shot and killed five people and wounded six others at the Hollywood Florida airport. Thirty-six other people sustained injuries in the ensuing panic. Attorney Myron May claimed he was being targeted by the same technology, he made three videos begging for help and put them on you tube just before he shot three people at the Florida State University. And then he was shot over 30 times and killed. I have also included his

videos in one of the two packages that I'm sending you. Jared Lee Laughner Killed a Federal Judge and a nine-year-old girl along with several other people and nearly killed congresswoman Gabrielle Gifford's in a supermarket parking lot in Casas Adobes Arizona, he also claimed to be targeted with mind control by someone in our Government. I sent Jared Lee Laughner a letter at the facility where he is being housed in Minnesota last year and the people in charge there refused to give it to him, instead they marked it refused and sent it back to me. I think they should have at least opened the package, read its contents then sent it to their nearest F.B.I. field office like Paulette D. Leach at the Ft. Leavenworth correctional facility did. When I called up to that correctional facility to ask if it was okay to write him a letter they seemed overly concerned and asked why I wanted to contact him. I told them that I felt that he had a lot more to say on the mind control issue that he had mentioned on tv the day of the shooting and that I felt he didn't get a chance to say all he had to say on that subject, and they said that I could write to him, but they wouldn't give me his mailing address. They said I had to look it up on the internet. So, I did. I know all of this sounds like paranoia and mental illness, but the evidence is there. I promise, you have Nothing to lose and everything to gain by exposing this illegal and inhumane operation against me and other American citizens buy the hands of some of the most inhumane and evil people that you can ever imagine. I truly believe that Major Nidal Hasan was also programed with this technology without his knowledge from other Government contractors to commit the first mass shooting at the Ft. Hood Tx. Facility. The lady in charge of him won't let me talk to him either. I sent a letter to him at the Ft. Leavenworth correctional facility back in 2017 and Paulette D. Leach sent my letter to the F.B.I. and about four months later two F.B.I. Special Agents from Johnson City Tennessee along with two Sheriff's Deputies from the Rogersville Tennessee Sheriff's office came to my home on a cold January day in 2018 and accused me of colluding with an enemy combatant. But it wasn't my intention to collude with Major Hassan, I just wanted to send him information about targeted individuals and ask if he had experienced any of the symptoms that other targeted individuals are experiencing before he lost his mind and went on his shooting rampage. I practically begged the senior Special Agent in charge that came to my home that day to investigate my story, he gave me a hateful look, like it made him mad and said with a hateful tone that he would. I haven't heard anything from him since and it's been over 16 months. As I mentioned

earlier, I am sending several hours of testimony on videos of other targeted individuals that I burned from you tube so that you and your colleagues can watch on your computers. You can google targeted individuals and [E.L.F.] mind control crimes to see for yourself that these types of crimes are going on and several other people are begging for help all over the United States and other countries as well. As far as I know, I'm the only targeted individual that has absolute undeniable proof along with several eyewitnesses from my National Guard service that proves my story is true and that these types of crimes are real and happening on a regular basis. If you really want to help stop school shootings and other mass shootings, then please help me expose my story. The C.I.A. gave Jim and Gerry Roberts four of those NASA computers to test on the public to see if they could be used as a weapon back in 1973. They started out causing car wrecks then they started going to all the local hospitals and targeted sick senior citizens to see how much pain they could withstand before dying. My Great grandmother on my dad's side, Minnie Parrott slipped in the wet grass in her yard and fell and broke a hip back in 1974, my Aunt Dolly called me on the phone and asked me to help carry her in the house. After we got her in the house, I called the rescue squad to take her to the nearest hospital, and that was the hospital in Rogersville Tennessee. That hospital is on the north end of Highway 11w up from Knoxville and Corryton Tennessee where Jim and his family were conducting their killing experiments. When my parents got home from work that same day my family and I got into the family car and went to the hospital to visit my great grandmother Minnie, but aunt Dolly wouldn't let any of us in the room with her, she said that grandmother Minnie was really upset and was saying that someone was reading her mind and trying to kill her. You can ask my dad Joe if you think this couldn't possibly have happen, He was there. So, we all went back home and sometime in the middle of the night we got a phone call saying that she had died. I asked Jim several times over the years if he had indeed killed my great grandmother Minnie and he repeatedly said yes, he did, and that he had killed several more of my family members over the past years also. He said that it is his job to do what the people on this program from the CIA hired him to do and he wasn't ashamed to admit it. Jim and Gerry hired several of their own family members from Knoxville and Corryton Tennessee that I mentioned earlier in this letter to help, along with at least four of their sons, James, Jerold, Keith and Curtis and several grandsons and at least two cousins that I know of, but I don't know their names. When Jim

And Gerry's sons hired on, they went from house to house reading people's minds and recording all their thoughts and then they took all the recordings back to Jim and he sent them to the C.I.A., that's how I got caught up in the targeting. They passed me on one of the roads near my home and then they followed me home and recorded my thoughts for several months after that, then Jim sent the recordings to the C.I.A. and then the C.I.A. decided that the Roberts family would use me as a guinea pig to test their equipment on. They wanted to use a younger victim to see how much I could take before I was mentally unstable and ready for programming like a Manchurian candidate, like Major Nidal Hassan and to see if they could make me suicidal. They also wanted to split my personality and cause me to develop schizophrenia. They would laugh at me while they were saying that they are going to crack me like a nut. And they tried hard to do just that, stopping just short of killing me several times. They gave me three heart attacks in the first thirty years of torture. They also used me to train eight more C.I.A. contractors from other States over the course of the first thirty years. They said that way I would be the only victim complaining to the proper authority's and no one would believe me and my unbelievable story, but they didn't take into account that stalking a long haul tractor trailer driver across the United States and Canada would leave a huge paper trail of receipts, I haven't been able to get any help from anyone the whole time up till this day. Some of the people that don't know about E.L.F. microwave technology thinks I'm crazy and other people that know fear being targeted themselves. When I reported the attack by my superior officers at my last Summer camp with the National Guard at Ft. Stewart Georgia back in the summer of 1981 to General Wallace at the Tennessee National Guard headquarters In Nashville Tennessee, He sent Lt. Colonel John Morrell to the armory in Morristown Tennessee Where I was stationed to interview and discharge me on my next Drill date. As I mentioned earlier, I have written my story down as best I can on a blog and I'm sending a copy of it with this letter to you. My penmanship isn't the best, I don't think I'll be winning a Pulitzer prize any time soon. So far, I have written three letters to President Trump that I mentioned at the top of this letter, one letter to Paulette D. Leach, she runs the correctional facility at Ft. Leavenworth Ks. Where Major Nidal Hassan the first Ft. Hood shooter is being housed, and two letters letter to F.B.I. supervisor Special Agent Karen L. Ferguson of the Nashville Tn. office, two letters to F.B.I. Special Agent in charge Troy A. Sowers of the Knoxville Tn. office, one letter to Pastor

John Hagee of San Antonio Tx, two letters to F.B.I. Special Agent Casey of 2620 Knob Creek Rd. Johnson City Tn. He is one of the two Special Agents that came to my home back in January of 2018 and accused me of collusion with an enemy combatant with Major Nidal Hasan. Two letters to the Secretary of Homeland Security Kirstjen M. Nielson of Washington DC, two letters to the Tennessee Bureau of Investigation of Knoxville Tn., one letter to Dibble & Miller. law firm of Rochester N.Y., one letter to Tennessee Congressman John Duncan of Washington DC., one letter to F.B.I. director Robert Muller of Washington DC, one letter to Tennessee Senator Lamar Alexander of Washington DC, two letters to Tennessee Attorney General Herbert H. Slatery III of Nashville Tn., two letters to F.B.I. Director Christopher A. Wray of Washington DC, one letter to Sean Hannity of Fox news of New York NY., two letters to the 84th Attorney General of the United States Jeff Sessions of Washington DC., and one letter to the First Lady of The United States Melania Trump of Washington DC., Two letters to Hawkins county Sheriff Ronnie Lawson of Rogersville Tn. One letter to you on Dec. 8th 2018, one letter to Vice President Mike Pence, one letter to wbir channel 10 news in Knoxville Tn., one letter to Alex Jones of Austin Tx. One letter to targeted individual Dr. John Hall of San Antonio Tx. and I sent one letter back to Kimberly T. Konkel, MSW Senior Public Health Advisor at the center for Mental Health services SAMHSA 5600 Fishers Lane, 14N46 Rockville Md. 20852 with my work history, blog and videos of other targeted individuals that I burned from you tube so she could have my story investigated for herself. One letter to House speaker Nancy Pelosi, one letter to Tucker Carlson of fox news in New York N.Y., one letter to acting Attorney General Whitaker of Washington D.C., one letter to U.S. Attorney James Douglas Overbey of Greenville Tn. One letter to the New York Times, one letter to the Washington Post, one letter to the National Enquirer, one letter to Tn. Senator Marsha Blackburn, one letter to Tn. Governor Bill Lee, one letter to Inspector General Michael Horowitz, one letter to The U.S. Secret Service of Washington D.C. And one letter to the U.S. Marshals of Arlington Va. I don't understand why nobody is taking an interest in my situation, there is a mountain of evidence and several eyewitnesses and nobody seems to care or wants to help me or try to help stop the mass shootings and the insane treatment of my family and other citizens. The only person I've heard back from is T.B.I. Special Agent JJ Sipos, that I mentioned in the top of this letter, he called me on the phone and said that he couldn't help me because the F.B.I. has jurisdiction. I am sending you

a copy of all the letters that I've sent out so far asking for help, they have all been sent certified mail. As I mentioned a couple of times earlier in this letter, I have my work history for the past twelve and a half years that shows the places and dates that I have picked up loads from and delivered to across the United State. I have run over one point four million miles for Big G Express out of Shelbyville Tn. I have been a long-haul tractor trailer driver since 1982 and I have driven over four million miles in my trucking career across the United States and Canada. C.I.A. contractors are like all contractors, they must save all their credit card, hotel, fuel, phone and food receipts to deduct from their Federal income tax every quarter to recover their out of pocket expenses. Verizon should have a lengthy record of most of their calls and locations that can be cross referenced with my work history sheets. There was a Trailways bus crash that happened back in 1973 with a tractor trailer on highway 11w near Bean Station Tennessee Jim told me that that was one of the first crashes that he caused using a NASA computer, he also said that he crashed another Trailways or Greyhound bus in that same area a little later on that killed several more people, and for several years after that he and his family gave highway 11w the nickname bloody 11w. from all the men, woman and children that they killed in automobile crashes just practicing and training other CIA contractors. One of the people that they killed was one of my high school teachers, Miss Andrews along with her two infant children, they all three was buried in the same casket. The crashes got so bad that Granger and Hawkins counties had to put in a four-lane highway to stop the wrecks. As I was saying earlier, Jim said that the devices they are using has a built-in recorder, and they record everything. Then he sends the recordings to the C.I.A. so they can study them. He also said that he has an extensive collection of recordings that he keeps for himself at his home. The recordings give him the felling of power and superiority over other people just by knowing everyone's personal business that he and his family encounter daily. [E.L.F.] technology can be used to cause heart attacks, especially if the victim has a pacemaker, and lots of other physical and emotional pain. I can't describe all the things this technology is capable of, but I have been through it all, repeatedly, for over forty years and when I see it being used on other people, I recognize it, like when it is used to cause mass shootings. That's why I'm so passionate about contacting all the mass shooters that survive, they have a fountain of information that nobody seems to know to ask. I feel that if I interview them, I possibly can help shed light on important issues that the

special investigators missed. The Roberts family is responsible for several hundreds if not thousands of deaths that most people don't know about. They have been literally committing genocide against the American people for over forty years. When I ask why they torture and kill so many people they say that the C.I.A. told them that the world is overpopulated, and they are doing the planet a favor. Jim's grand son James Roberts told me that he has already killed twenty-three people and he is only twenty-four years old. He said that he tries to kill two people every day on his way from his home in Knoxville Tn. To my Home in Whitesburg Tn. when I'm on my home time to catch up with his relatives that has been working on this program.
